A. WAIVER AND INDEMNITY

1. I participate at Dezzi Raceway at my own risk.
2. I hereby waive and abandon any claims, or whatever nature, arising from the use of me by Dezzi Raceway, whether resulting from death, bodily injury or otherwise which I may have against Dezzi Raceway and/or the ORGANISERS from whatever cause.
3. I hereby indemnify LOUD ADDICTS and/or the ORGANISERS against all and any claims of whatsoever nature, which may be instituted against LOUD ADDICTS and/or the ORGANISERS arising from the use by any participant and/or person of LOUD ADDICTS, while I participate at Dezzi Raceway.
